PASTOR'S POST

Dear Faith Members and Friends,

February was action-packed, and March will be the same!

One of the highlights of February was Cowboy Sunday. Thanks to our Music Director Janis Wheat and Elder George Wheat for their work in landing the amazing recording artist and all-around wonderful human being Joni Harms to play for us on Cowboy Sunday. I thought it was a great celebration! And of course, the Gaslight Theater outing for Faith was once again an amazing experience of fun and laughter and fellowship. As we turn the calendar over to March, we enter the time of preparation and reflection for Lent. Please join us for soup and bread on Ash Wednesday, March 5, at 5 pm, followed by worship and imposition of ashes at 6:15 pm. Ash Wednesday is a solemn service where we officially begin the Lenten season. In the ancient days of the church, the time of Lent was a time where people would study and prepare to be baptized on Easter. 

Dear Members of the Faith Presbyterian Church Congregation:

In January my term on the Monture Council ended (although I continue to assist the Council as a member of the finance committee). When I joined the Council in 2020, Montlure was closed because of the Wallow fire and subsequent flooding. At that time, Council members and volunteers participated in numerous work camps to maintain and repair the facilities.

The Council also engaged in intensive fund-raising efforts to cover the costs of necessary repairs, rental of other camp facilities, and the operational costs of travelling day camps and on-site summer youth camps. Additionally, Council leaders worked with and encouraged the Forest Service to complete the studies and paperwork required to once again use the Greer facilities.

After a great deal of effort by the Council, the Forest Service finally provided Montlure Greer with a temporary permit to use the facilities for 2024 on-site summer youth camps. This made a great positive difference because for many years, the Council had been forced to rent facilities. The Council and the Forest Service are now working to facilitate a land exchange that would give Montlure ownership of the site upon which the Greer Camp is situated.

Making Montlure fully ready to accommodate youth camps and other similar activities for various Presbyterian and other Christian groups will require many volunteer hours and many dollars. The Council greatly appreciates your past support and hopes that you will support Montlure and its important mission in 2025.

MONTLURE UPDATE

Greer

Since the Wallow Fire of 2011, we have had a unique opportunity to watch the rebirth of a forest at our home camp site in Greer. Please read below for a current update, and email <u>camp@montlure.org</u> for further questions.

Thank you to the countless volunteer hours and gracious donors, past and present Council members, volunteers providing professional services, and our greater camp community for all the support over many years to help us make a return home a reality.

Current Update

Since being displaced by the 2011 Wallow Fire, Montlure hosted camp in Greer during the summer 2024 season, and our special use permit extends for the 2025 season!

It is hard to believe the number of hurdles Montlure has faced with reopening our facilities in Greer, but we brought our campers home to our beloved site this past summer!

In late 2021, by request of the United States Forest Service, the Montlure Council applied to begin the lengthy National Environmental and Protection Agency (NEPA) approval process. As of the fall of 2023, the USFS and the Montlure Council came to a solution that allowed us back on the site as-is (pending some safety and environmental mitigations that were put into place) as we continue to go through the NEPA review which will last several years. With this agreement, we will be able to restore and renovate the current buildings and amenities which allows for proper accommodations for our campers and staff.

On March 21, 2024, Montlure received the final notification from the Forest Service regarding this agreement and the reinstatement of our Special Use Permit to use the facilities in Greer for our Summer 2024 program!

The Montlure Council and facilities team devised a comprehensive plan for the necessary cleaning, repairs, and renovations required to open our site for summer camp in 2024. With the outpouring support of the Montlure community through financial donations and countless volunteer Service Camp hours, we made reopening a reality.

Montlure continues to work with the USFS on long term strategies and mitigation plans as the NEPA process continues. We earnestly ask for continued prayers as we navigate through this lengthy process.

Currently, through **2/22/2025**, the USFS has opened the public comment phase of the NEPA review to gain a categorical exclusion for our restoration efforts, as well as a 20-year permit. (Our current permit is temporary through the end of 2025.)

In the meantime, as we continue to work on long term solutions, our site has a lot of work needed and we will resume a



robust Service Camp schedule in the Spring. In addition, we humbly ask for the ongoing financial support of our community to help with the current repair, renovation, general upkeep of maintenance, and proper insurance on our site through our **Friends of Mont-lure** giving fund.
